Thanks to the generous support and joint venture of Coca-Cola Bottling of Alaska and the Odom Corporation, ALPAR is offering grants to be used for the purchase aluminum can crushers (either small hand-operated and/or larger mechanized versions such as balers).

Eligibility: must be a nonprofit or federally recognized tribe (must supply an IRS tax ID number to qualify).

Preference: entities active in ALPAR Flying Cans and/or communities without the ability to recycle cans locally.

Timing: applications are due March 1, 2022

Documentation: all applicants must provide a description/need for the grant, goals, receipts and outcomes. Those seeking grants over \$250 will be asked for a budget, timeline and other sources of funding.

- *delivery charges are not allowed, however you may use the funds as part of a matching requirement.
- *choice of vendor/supplier of can crusher equipment is yours as is arranging to receive the equipment.

Verification terms: *those unable to comply with the terms below will be asked to return funds (ALPAR will invoice)

- 1. receipts must meet or exceed the grant issued and must be provided within 90 days after funds are released;
- 2. sponsor sign (supplied by ALPAR) must be displayed above/near equipment purchased; and
- 3. photos of equipment in use by volunteers/staff with sign in background must be emailed to ALPAR within 90 days of receiving equipment (no hard copies or faxed photos accepted).

Release of funds: checks and sponsor sign will be mailed by ALPAR on or about April 1, 2022
